Further agreements concerning any program shall provide details concerning the specific commitments made by each party and shall not become effective until they have been reduced to writing, executed by the duly authorized representatives of the parties.

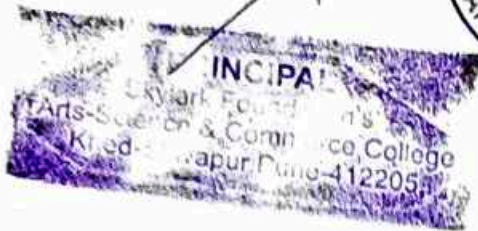


Either party may withdraw from this MOU provided written notification of the withdrawal is given to the other party at least three months prior to the desired withdrawal date.

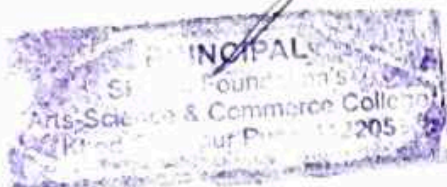

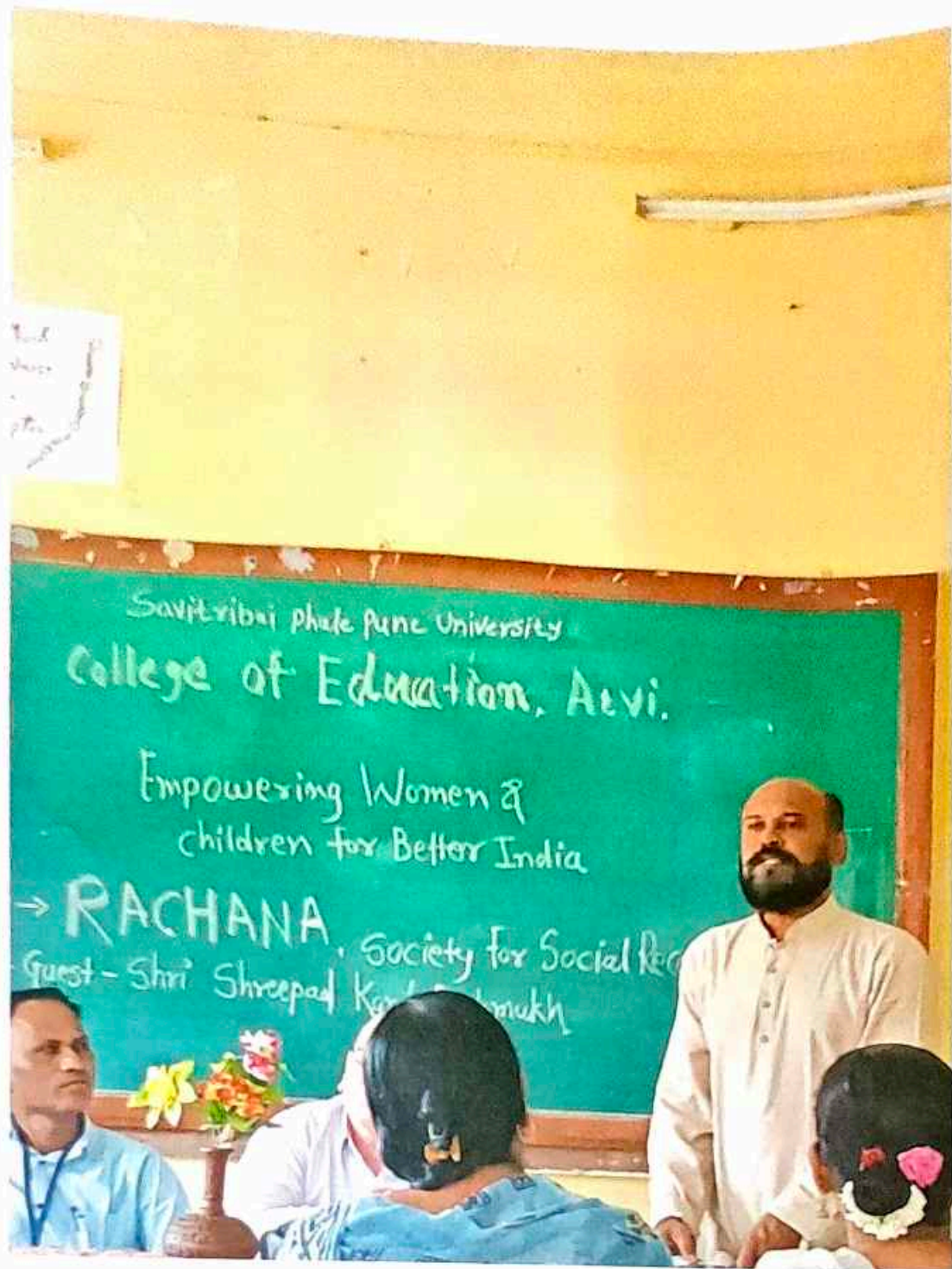
